In addition, remove the CoDA Board of Trustees Application from the Fellowship Service Manual (FSM).

CoDA Board of Trustees Position Description

Trustees adhere to the principles of our program while conducting service work. Specifically, they use Step Ten for guidance and insight and adhere to Tradition Two as they honor the validity of the group conscience process. This service position is demanding, and therefore the potential for reward through recovery is also great. CoDA Board service is great and rewarding Twelfth Step work.

An Alternate Trustee is expected to:

- Learn each function of a Board member
- To have the opportunity to learn how to be a voting member of the Board of Trustees, how the Board functions. Voting Board members may serve as a mentor/sponsor to the alternate to help the alternate learn the roles of secretary, treasurer, etc.
- Immediately after being elected, read the Fellowship Service Manual, Bylaws, Articles of Incorporation and become familiar with the Arizona Revised Statues Article 10
- Undertake liaison responsibilities for one or more CoDA Committees, several Voting Entities, to special workers and/or projects/work groups as assigned.
- Agree to function in a responsible manner, which includes:
- o Consistently attend and participate in the group conscience discussions (but no vote) during Board meetings and at Service Conferences. If voting, accept outcomes even if you disagree.
- o Consistently read and respond in a timely manner to emails to and from the Board using the assigned Microsoft 365 Outlook, OneDrive, etc. account assigned to you. Agrees not to use a personal email account.
- o Prepare reports and participate in projects or other assignments agreed upon and present them in a timely manner.
- o Meet deadlines as set forth by the Board.
- o Recognize his/her time limitations and notify the Board promptly of any time conflicts.
- Substitute for a voting member when he/she is not present. If there is only one voting member absent, and there is more than one alternate, the order is predetermined by the election at CSC. If there is no predetermination, then the board will take a GC to determine who will substitute. If there is an equal number of absent board voting members and alternates, the substitution takes place automatically.
- Alternate and Interim Trustees can serve as CoDA committee members but cannot simultaneously serve as chair of a standing committee. If they become a Trustee or are able to vote at any time, they must resign from the committee as a member but may participate as a Board Liaison.
- Alternate and Interim Trustees may not serve simultaneously the Voting Entity Liaison (VEL).
- Alternate and Interim Trustees may serve as a delegate or officer at the level of Intergroup or Voting Entity. An Alternate Trustee will have no vote at Conference unless serving in the capacity of Delegate. However, if the applicant has not attended a CoDA Service Conference (CSC) in the last three years, they may attend the current conference, in its entirety, then submit their application to the Board of Trustees at the conclusion of the conference. If the applicant meets stated requirements, their ratification will take place at the next conference. Elected Trustees replace outgoing Trustees and assume their positions, prerogatives and responsibilities at the end of the Conference. Alternate Trustees are elected by the Conference for one (1) year. The order in which they would fill vacancies on the Board is designated by the vote of the Conference at time of election.

#### Intent:

The Australia VE, jointly with the CoDA Literature Committee requests that The First 14 Days be endorsed in 2025 as a service item to be posted on the coda.org website under Member Resources. We also request that there be a slider on the website announcing that it is available.

#### Intent:

The First 14 Days is a simple, structured introduction to Co-Dependents Anonymous (CoDA) recovery. It offers newcomers a gentle entry into the Co-Dependents Anonymous program, while also providing an accessible and low-pressure way for members to serve as temporary sponsors. The intention is to support both sponsees and temporary sponsors in a safe and non-directive space, fostering clarity, honesty, and early recovery engagement.

This initiative arose from a need observed within some CoDA communities, where a small group of long-time members often found themselves sponsoring multiple newcomers, while many others felt hesitant to step into the role

This process has been working throughout CoDA Australasia for the last twenty years. The First 14 Days was developed to demonstrate that anyone with a willingness to serve can support others by simply walking beside them without needing to offer advice, direction, or therapeutic insight.

For the sponsee, the workbook helps identify personal patterns of co-dependency, particularly behaviors that have caused pain or unmanageability. It encourages honest self-reflection and introduces key principles of the program, ultimately serving as a foundation for a deeper Step One and ongoing recovery.

The temporary sponsor's role is intentionally straightforward. They email the exercises one at a time to the sponsee, acknowledge each response with a brief thank-you, and then send the next exercise. This exchange mirrors a CoDA meeting, offering presence and support without interference.

At the conclusion of The First 14 Days, sponsees are encouraged to take someone else through the process and to seek out a permanent sponsor to begin working the full CoDA Twelve Steps. In this way, The First 14 Days supports both individual growth and the expansion of service within the Fellowship.

#### Remarks:

The First 14 Days is a practical tool for building connection, deepening self-awareness, and strengthening CoDA's tradition of recovery through service. It also empowers more members to serve as temporary sponsors by providing a structured, low-pressure format.

It is not a substitute for working the Twelve Steps.

As a new part of CoDA, CoDAteen needs the support of the CoDA fellowship to ensure the continuance of its growth and sustainability. Preventing CoDAteens from meeting at an international level blocks growth and harms the growth of CoDA as a whole.

The CoDAteen community are teens and young adults seeking recovery from codependency. These individuals are the future of CoDA as they continue to make positive changes in their lives. CoDA must make every effort to assist and facilitate these young people in their recovery journey by providing an alternative so they may learn how to have healthy and loving relationships.

We answer both general and specific questions about CoDA, and share our experience, strength, and hope (ESH). We refer others to specific CoDA Committees when they miss that reference on the recorded menu. The basic idea is to briefly answer whatever question the person is asking.

We are not a counseling or crisis hotline, nor can we refer them to one, so we indicate that to the caller. But we still try to be warm and communicative about CoDA as a resource for people desiring healthy and loving relationships. Calls to C-phone volunteers are automatically forwarded to those "on-call" at the time of the call or go to a message recording system. These recordings are then accessed by the next person on call, and then the call is returned. People serving on C-phone should have at least one year of active CoDA recovery.

We have Trusted Servant(s) that actively attempt to contact meetings to verify that their meeting is still active and that their meeting information posted on the CoDA.org website is accurate. The accuracy includes meeting contact(s) verification. We assist in updating domestic, regional, and international contact information and meeting lists by forwarding information to the appropriate Fellowship Service Worker (FSW). verifymeetings@coda.org

At the close of the accounting period, all records of accounts and an inventory of assets shall be submitted to an independent accounting firm who is to submit a report of their findings to the Trustees. The Trustees shall present the report to the Fellowship at the next CoDA Service Conference. The officers of the Corporation shall maintain an accurate and complete set of records at the Corporations office. If the Corporation does not maintain a place of business with Arizona, a complete set shall be maintained at the office of its statutory agent or other such designee as approved by the Board of Trustees. Upon written request, records and minutes of meetings may be inspected by a member of the Fellowship, at any reasonable time, with the exception of certain legal documents and personnel records.

Article II- Accounting Period, Financial Review and & Nonprofit Board Governance Consult and Records

The accounting period of the Corporation shall be a calendar year and end on December 31. At the close of the accounting period, all records of accounts and an inventory of assets shall be submitted to an independent accounting firm to perform a Financial Review by an independent third party and audit required by reviewer the Internal Revenue Service (I.R.S.) and submit a report of their findings to the Trustees. The Trustees shall present the report to the Fellowship at the next CoDA Service Conference. In addition to the annual Financial Review, the Trustees shall have a Non-Profit Board Governance consultation completed every 3 years that will be included with the Board's annual report at the CoDA Service Conference in the calendar year the consultation is completed. The Boards annual report will also include an action plan to address any governance gaps identified in the Governance Review. The officers of the Corporation shall maintain an accurate and complete set of records at the Corporations office. If the Corporation does not maintain a place of business with Arizona, a complete set shall be maintained at the office of its statutory agent or other such designee as approved by the Board of Trustees. Upon written request, records and minutes of meetings may be inspected by a member of the Fellowship, at any

reasonable time, with the exception of certain legal documents and personnel records.

- Perform analytical and detailed transactional testing of significant expense areas

The Finance Committee advises the CoDA Board in promoting responsible spending and transparency. The current advisement is for an annual review and not a full audit. In addition, the Committee advises the completion of a Non-Profit Board Governance consultation every three years. A full report of the annual financial review is to be included in the Board's report at the yearly CoDA Service Conference. A full report of the Non-Profit Board Governance consultation is to be included in that year's Board report at the CoDA Service Conference (CSC).

The need for a full financial audit is only realistic if required by a governing body. The excessive cost is not prudent for the monetary resources of the CoDA Fellowship.

This change does not prohibit a full audit of the records and inventory of the corporation if it is warranted. It is advised in the spirit of accountability and prudent expenditure of our resources to request a financial review every year and a Non-Profit Board Governance every third year.

Changing the wording from "Audit" to "Financial Review" clarifies the intent of this article and allows for a regular review that will be less expensive and more specific to Fellowship inquiries than a full audit of records on a yearly basis.

Each voting entity has the authority to conduct and valid its own delegate elections through its established group conscience process. CoDA service bodies at all levels are encouraged to respect the autonomy of each voting entity and to recognize its responsibility of the conduct and outcome of its own elections. If a voting entity identifies an internal concern, it resolves this through its own group conscious. In rare cases, where an election clearly conflicts with CoDA Bylaws, legal obligations or the Fellowship's Traditions, the matter may be referred to a CoDA Service body designated to review such concerns and if necessary, provide a recommendation to the CoDA Service Conference (CSC). Although it guides the Fellowship, it does not have authority over the preeminent rights of the any group or voting entity.

#### Intent:

This motion seeks to reaffirm and clarify the spiritual principle that each Voting Entity (VE) governs its own internal processes, including delegate elections and service structure development, through group conscience. It clarifies that no CoDA service board, committee, or individual may override or interfere with those decisions unless formally empowered by the CoDA Service Conference (CSC). This proposed amendment addresses that gap and affirms Tradition Two and CoDA's bottom-up service structure.

#### Background

In 2025, the UK National Service Committee (NSC) elected two Delegates to represent their Voting Entity at the upcoming CSC. The CoDA Board with the Voting Entity Liaison later declared both elections invalid, citing that some voters were affiliated with another Voting Entity (Intergroup North & Regions). The National Service Committee did not dispute the election, and no specific FSM or Bylaws clause prohibits such participation.

Motion Name: Reinstating the Issues Mediation Committee (IMC)

MOTION: To re-instate the Issues Mediation Committee (IMC) from a Workgroup to a Committee immediately. Reelect the 2024 IMC standing members, and to update and clarify the Bylaws as outlined below to make the IMC a permanent committee codified in the bylaws and affirming the placement and duties of the Voting Entity Liaison (VEL). The delegates will consider holding a special election immediately following conference to elect new 2025/2026 Issues Mediation Committee (IMC)) members. The newly elected Issues Mediation Committee (IMC) will have six months to complete any minutes or reports that have not been updated by the end of CSC 2025.

In the CoDA Bylaws – Article VI "Committees" INSERT (immediately following the first paragraph in this section):

The Issues Mediation Committee (IMC) shall be a permanent standing committee due to its responsibilities in Voting Entity splits, liaison duties, and Fellowship mediation, as outlined in the Fellowship Service Manual (FSM). The members are past and/or present delegates elected annually by conference. The Voting Entity Liaison (VEL) and Vice-VEL shall serve within the IMC as outlined in the Fellowship Service Manual and the Bylaws herein.

The VEL of the IMC shall maintain the roster of vetted Delegates and Alternate Delegates for use by the VEL, the CoDA Events Committee (CEC), the CoDA Board of Trustees, and the Delegate Relations Committee (DRC) for communications during and between the annual CoDA Service Conference (CSC). The VEL shall act in a neutral capacity and refer all Voting Entity or Delegate disputes to the group conscience of the IMC. The VEL or IMC shall not define or modify any Voting Entity's internal voting rules or membership criteria.

#### Intent:

- Put the neutral IMC back in place to handle Voting Entity splits, mediation, and the Voting Entity Liaison role.
- Updating the bylaws to include IMC as a permanent committee due to its importance in being a neutral body to handle mediations etc..
- To put the VEL back into the structure of the Issues Mediation committee to align with the CoDA bylaws as currently written
- Ensure Delegates actually get notices and have a reasonable means of maintaining communication throughout the year by keeping one complete, shareable list.
- Ensure and affirm Voting Entity (VE) autonomy as outlined in the Service Concepts, Twelve Traditions, Fellowship Service Manual and the CoDA bylaws.

Changes by the Board of Trustees to the Issues Mediation Committee based on being demoted to a workgroup occurred this past year, resulting in the VEL being moved to the Events committee and the IMC not being allowed to fulfill its duties in Voting Entity splits, Mediation roles, Delegate verification etc.. These actions have led to a big

gap and lack of neutrality in the IMC committee duties being re-assigned to other committees and at times the Board taking on those responsibilities themselves. The VEL was placed in the Events committee which is not supported by the Bylaws or the FSM in regard to the role and duties of the Events Committee vs. the Issues Mediation Committee. The legal stance by the Board is met with the statement that the IMC committee will have all of its minutes completed within a certain timeframe.

#### Supporting Bylaws for the above request:

Article IV, Section 2: The Issues Mediation Committee will handle requests for CoDA, Inc. to recognize Voting Entities. Through the group conscience process, Voting Entities select Delegates and Alternate Delegates to carry the will of the membership of CoDA, Inc. meetings. In order to guarantee voting rights, each Voting Entity service board must be duly authorized by the Issues Mediation Committee. In the absence of a Voting Entity service board. members of that Entity shall present an alternative selection process based on group conscience decision making to the Issues Mediation Committee. This procedure insures adherence to the program of recovery endorsed by this Fellowship.

Section 3. Voting Member Selection/Election A Delegate (Delegate) is a member and trusted servant in the CoDA Fellowship of the Voting Entity represented and has an active interest in carrying the message to other codependents who still suffer. The Delegate is duly selected/elected by a method which the Voting Entity where the member resides or provides service work has established, and is to be that Voting Entity's representative at Conference.

- Traditions: 2: For our group purpose there is but one ultimate authority a loving Higher Power as expressed to our group conscience. Our leaders are but trusted servants; they do not govern.
- Tradition 4: Each group should remain autonomous except in matters affecting other groups or CoDA as a whole.

QUESTIONS - (Yes) Crafting (Yes) PROS & COŃS:

- 8: The CoDA Service Conference (Conference), through its group conscience decision making process, guides the Fellowship in making policy decisions and in following the Twelve Steps and Twelve Traditions. The Conference, though providing guidelines, holds no authority over the decision making process of individual groups. The group conscience process is our decision making process. Failure to honor this process may violate Traditions One and Four and a sanction may be imposed. The harshest sanction Conference can impose on an individual or group is to no longer recognize it as belonging to CoDA; this sanction may only be imposed on those who consistently violate the Twelve Steps and Twelve Traditions, as determined by guidelines accepted by Conference.
- 9. By tradition, the CoDA Service Conference gives responsibilities to working committees composed of Conference Delegates and other CoDA volunteers or to

separate service boards or corporations. All are directly responsible to the Conference. The scope of the work a committee does is determined by the Conference group conscience. The chairperson of each committee assumes the responsibility to ensure the work assigned to the committee is completed in a timely manner.

Such action must be limited strictly to resolving that certain situation and must be reported to and ratified by the next regular Service Conference.
- 9. Nullification: Any Board policy or action that conflicts with the Fellowship Service Manual or Bylaws, except as narrowly allowed under the Exception, shall be considered null and void and have no effect within CoDA World Service.

#### Intent:

This motion clarifies the role of the Board in relation to conference decisions codified in our Fellowship Service Manual and gives a narrowly scoped exception clause referencing Service Concept Eleven. #### **Description:**

Motion Name: Formation of a Task Force to Define the Fellowship-Initiated Special Meeting Procedure

Motion – Move that a Special Meeting Task Force be formed to define and recommend procedure including possible CoDA Bylaws or Fellowship Service Manual (FSM) amendments that enable the Fellowship to initiate and convene a Special Meeting of the Delegates between annual Conferences, as referenced in Article V, Section 5 of the CoDA Bylaws.

The purpose of the Task Force is to provide a clearly defined, spiritually guided process for Fellowship- initiated Special Meetings. This includes outlining steps for initiating, validating, and communicating a Delegate petition, clarifying the roles of CoDA service bodies (such as the Board, Events Committee, Delegate Relations Committee, and Voting Entities), and proposing how such a meeting would be facilitated.

The Task Force shall:

- Develop written procedures to operationalize the Bylaws reference to Fellowship-initiated Special Meetings.
- Develop a way for Delegates to stay connected, if they choose and discuss Fellowship-wide issues throughout the year, either to prepare for a possible Special Meeting or CoDA Service Conference, or to foster

understanding that may make a Special Meeting request unnecessary.

- Identify gaps or ambiguities in the current Bylaws and Fellowship Service Manual (FSM) language.
- Submit possible Bylaws and/or FSM amendments for CSC 2026 review and approval.
- Complete its task and submit a full written report to the 2026 CSC

#### Membership may include:

- One (1) member from each of the following: the CoDA Events Committee (CEC), Delegate Relations Committee (DRC) and Issues Mediation Committee (if the IMC is re-instated)
- At least three (3) Delegates or former Delegates from recognized Voting Entities
- One (1) CoDA Board liaison (ideally the CoDA Board Secretary) who may offer input and guidance will be a voting member of the Task Force.
- Committee chairs and members welcomed
- Other interested CoDA members to support its purpose.

#### Intent:

While Article V, Section 5 of the CoDA Bylaws references the Fellowship's ability to call a Special Meeting through a petition by two-thirds (2/3) of Delegates from the previous CSC, the Bylaws do not provide any detailed procedural framework to support the implementation of this right. Specifically, there is no guidance on how petitions are initiated, how contact and communication among Delegates occurs, how verification is managed, or how such a meeting would be coordinated by the Board Secretary and/or the CoDA Events Committee and facilitated within CoDA's structure. The lack of clarity presents an operational barrier and discourages use of this mechanism, despite its foundational importance to address Fellowship concerns between conferences.

#### Remarks:

In 2024, NorCal submitted Motion 24096 requesting the formation of a Task Force to define a Fellowship-initiated process for calling a Special Meeting. The motion passed by a simple majority but did not meet the two-thirds (2/3) threshold and was therefore not recognized as binding by the Board.

Following CSC 2024, the Board exercised its own authority—by a two-thirds (2/3) Board vote—to call a Special Meeting of Delegates and held two Board-led sessions. However, under Article V, Section 5 of the Bylaws, Delegates also have the right to call a Special Meeting by petition of two-thirds (2/3) of the prior year's Delegates. That Delegate-initiated process remains undefined and unclear.

NorCal also submitted a petition to the Board following CSC 2024 requesting a Delegate-initiated Special Meeting to address Fellowship concerns. This request was not addressed, and no petition was circulated to Delegates.
